

The reorganization of the Employment Programs folder that began on September 14 is complete.

As outlined in previous notifications, a project began in May 2018 to simplify the Employment Programs folder in WebI and to make the folder easier to navigate. Since May 2018, unused reports were archived, and during the most recent phase of the project, the Employment Programs folder was reorganized to group reports by topic, reducing the number of folders and subfolders from 50 to 33.
