A section on W-2 Supportive Service Plans was added. The chapter has been renamed W-2 Placements. For clarity, the entire chapter was significantly rewritten and the section numbering updated. The chapter is now organized by placement type – Unpaid, Trial

Jobs, Paid, and Other Case Management Placements.

As part of the Manual reorganization, Chapter 14 - *Groups Eligible for Case Management and Other Services*, has been incorporated into Chapter 7. Two Parent policy has been moved into Chapter 14 which is now entitled *Two*

Chapter 18 As part of the Manual reorganization, Chapter 18 has been moved to Chapter

19 and renamed *Other W-2 Resources*. For clarity, the chapter was significantly rewritten and the section numbering updated. The section on Emergency Payments has not yet been updated. Sections on the following have been deleted from the chapter: FoodShare, Low Income Home Energy Assistance Program, Low Income Weatherization Program, Medicaid, Caretaker Supplement, SSI/SSDI Advocacy (moved into Chapter 7), and

Community Reinvestment. (See chart below)

Chapter 19	As part of the Manual reorganization, Chapter 19, which was previously reserved, is now entitled <i>Other W-2 Resources</i> . (See chart below)
Chapter 20	As part of the Manual reorganization, Chapter 20 – Refugee Assistance Program, has been moved to Chapter 18 and converted to online format. (See chart below)

**W-2 POLICY MANUAL REORGANIZATION

The following changes will be made to the W-2 Policy Manual to increase the logical flow of information. Chapter and section references will be updated as chapters are moved. If a chapter that is already in RoboHelp moves from one location to another, all of the related history will move with it. For example, the Dispute Resolution Chapter is already in RoboHelp and moved from Chapter 19 to Chapter 12 in Manual Release 11-06. Once the move was made, W-2 Manual users could find history for a particular Dispute Resolution policy by going to the current section in the Manual (which is now in Chapter 12) and clicking "View History" on the top right corner of the screen.
